Jay W. Chadwick is Executive Chairman, President, Chief Executive Officer, and member of the boards of directors of Tuscarora Wayne Mutual Group, Inc., and Susquehanna Capital Corp. He is Executive Chairman and member of the boards of directors of Tuscarora Wayne Insurance Company, Lebanon Valley Insurance Company, Keystone National Insurance Company and Capital Insurance Company; and Chairman of the Tuscarora Wayne Mutual Group Foundation. Headquartered in Wyalusing, Pennsylvania, these companies specialize in underwriting and distributing property and casualty insurance in the Commonwealth of Pennsylvania, Ohio, Kentucky, and Indiana.

Mr. Chadwick joined Tuscarora Wayne in 1985; he was elected President and Chief Executive Officer in 1993, and Chairman of the Boards in 2015. He began his insurance career in 1978 with the St. Paul Companies, holding various positions in their



underwriting and marketing divisions in Wisconsin, New York, and Massachusetts. Professionally, Mr. Chadwick served as a member of the National Association of Mutual Insurance Companies' Board of Directors (NAMIC) and the NAMIC Property/Casualty Conference Board of Directors. He was Chairman of the Pennsylvania Association of Mutual Insurance Companies; Chairman of Mutual Inspection Bureau; and Vice Chairman of Eastern Mutual Group.

He is active in the community, serving as a Director and Chairman of Peoples, Ltd. and PS Bank Boards of Directors; Guthrie Health System (GHS) Board of Trustees; a member of the GHS Investment Committee; and a board member of The Fund for Northern Tier Development. He is president of the Lebanon Valley Insurance Company's Foundation. He is co-founder and member of The Hayseed Group, LLC (subsidiaries include Stonehedge Partners, LLC; Dieci United States, LLC; West Wyalusing, LLC); general partner of Chadwick Energy Partners, LLC, and a limited partner of Chadwick Limited Partnership. He served as a member of the GHS Board of Directors; Chairman of the GHS Investment Committee; member of the GHS Finance Committee; Chairman of the Central Bradford County United Way; Chairman of the Camptown Men's Club, Inc.; and is a founding board member of the Wyalusing Area Education Foundation.

Mr. Chadwick holds a Bachelor of Science Degree in Business Administration with a major in insurance and real estate from the Pennsylvania State University. He attended the University of Pennsylvania's Wharton School on Strategic Alliances, and the Penn State Executive Development Institute. 


Gerald (Jerry) & Eleanor Parsons

Robert Pullo

United Way of York County

Robert W. Pullo is Chairman of the board and Chief Executive Officer of Waypoint/York Federal Foundation. Now retired from banking after a career spanning 47 years, Mr. Pullo joined York Federal Savings and Loan in 1976, successfully leading the bank to become a publicly traded company and accomplishing two ensuing mergers. He is considered one of York County's most prominent financial leaders and most generous philanthropists, having raised more than \$100 million for York-based nonprofits.

Mr. Pullo and his wife, Donna, are longtime members of the Tocqueville Society and staunch advocates for United Way of York County. Mr. Pullo served a five-year term as Chair of the Tocqueville Cabinet, during which time, membership increased 83 percent, and he was an early supporter of United Way's Focus On Our Future early learning initiative, which celebrates its 25th anniversary in 2020. Mr. and Mrs. Pullo are the first



members of the Million Dollar Roundtable through a \$1 million gift in 2002, the largest gift received to date by United Way of York County. They were named 2009 Philanthropists of the Year by Central Pennsylvania Chapter of the Association of Fundraising Professionals.

In 2018, alumni of the York Federal Fellows, a nonprofit leadership program founded by Mr. Pullo in 2006, launched Give Local York, a one-day "big give" fundraising event to benefit nonprofit organizations throughout York County. The event raised more than \$3 million in 2019, with more than 300 nonprofits benefitting.

Originally from Somerville, Massachusetts, outside Boston, Mr. Pullo resides in York with his wife, Donna. They have four grown children, Robert, Jr., Julie, Susan, and Tracey; five grandchildren; and two great-grandchildren.
