Throughout his business and civic life, Max Gannon has succeeded because of his commitment, not only to business success and personal achievement, but to his family, community, clients, employees, and the causes in which he fervently believes. The son and namesake of an educator, Max P. Gannon, who oversaw the consolidation and subsequent administration of the Wyalusing Area School District for about 25 years as its Supervising Principal/Superintendent, Max was the youngest of four siblings. Max graduated from Wyalusing Valley High School in 1967 and the Indiana University of Pennsylvania before launching his impressive career in the insurance field as an agent in 1972.

Barely a year later, Max, still in his early twenties, struck out on his own and founded Gannon Associates, Inc., which grew into a regional agency it is today with 10 offices in Pennsylvania and New York and more than 70 employees. He grew up in Bradford County, PA, where the agency is headquartered. The county has historically been an agricultural leader in Pennsylvania, and Max became not only an authority and innovator in the insurance field, serving on various insurance boards, but his knowledge about the challenges facing farmers as they crossed the threshold of the 21st Century made another transition possible.

Max took over as President of Agri-Services Agency (ASA) in 1999 and his son, Mark, now heads the day to day operations of Gannon Associates as its Chief Executive Officer. Between the two agencies, they now employ over 112 employees and service customers in every state. Under Max's leadership ASA Under Max's leadership ASA has been able take a leading role in uniting farmers in an innovative cooperative business model to protect themselves, their businesses and their lifestyles through farm, health and life insurance and workers compensation just like employees and executives of major industries.



As a citizen, Max has served his community on multiple levels, from being a volunteer ambulance driver to chairing the boards of his local hospital and industrial development authority. As a founder of the United Way in Bradford County and his tireless efforts on its behalf, his many contributions are stated in his nomination letter.

Thomas Bailey Hagen, a business and civic leader for more than 50 years, is Chairman of the Board of the Erie Insurance Group companies where he began as a part-time file clerk in 1953, retiring 40 years later as Chairman & CEO. Erie Insurance is the largest employer and the only Fortune 500 company headquartered in Erie County.

He is also Chairman of the Board of Custom Group Industries, the collective name for the three Erie, Pennsylvania based manufacturing companies in which he has had an ownership interest since 1997: Custom Engineering Co., Venango Machine Company and Lamjen, Inc.

Long identified with community development and historic building restoration, Hagen is an Advisory Board member and former officer and director of Preservation Pennsylvania. He was a founder and President of the former Erie Tomorrow Corporation, and a founder and past Vice Chairman of the Bayfront East Side Taskforce (B.E.S.T.) in Erie. He is also a former Board member, officer and Honorary Director of the Erie Conference on Community Development (now the Erie Regional Chamber & Growth Partnership) and former board member of the Chautaugua Foundation and The Erie Community Foundation.

On August 29, 2015, the campus of the Historical Society of Erie County (PA) museum and archives was designated the Thomas B. Hagen History Center. And, on October 22, 2015, Hagen was awarded the highest honor for historic preservation in Pennsylvania, "The Otto Haas Award" from Preservation Pennsylvania. He has received dozens of other awards that are too numerous to list, including United Way's Tocqueville Award in 2009.



Mr. Hagen is Co-Founder, Past Chairman and Director Emeritus of Team Pennsylvania Foundation; past Chairman of the Pennsylvania Chamber of Business and Industry; past Chairman of the Insurance Federation of Pennsylvania; past President and Honorary Director of the Erie Philharmonic, and Past President and Councilor Emeritus of the Pennsylvania Society. He currently serves as Vice Chair of the Pennsylvania Housing Finance Agency and as a Trustee of The New England Historic Genealogical Society (NEHGS).

A retired U.S. Navy Captain, Hagen served on active duty during the Cold War as Supply Officer of the Atlantic Fleet destroyer USS Harwood and on Reserve duty with the logistics staff of the Commander-in-Chief, U.S. Atlantic Fleet for a total of 30 years service.

Born in Buffalo, NY, Hagen was raised in Erie, where he attended public schools and graduated from Strong Vincent High School. Hagen attended Penn State Erie, The Behrend College and graduated in 1957 with a BS Degree in Business Administration (Insurance) from The Ohio State University, where he was a Griffith Scholar, President of the Insurance Society and Treasurer of Phi Kappa Psi Fraternity.

Edinboro University of Pennsylvania conferred on Hagen the honorary degree of Doctor of Public Service in 1996 "In recognition of [his] leadership in the cause of civic and social responsibility..." and Mercyhurst University conferred on him the honorary degree of Doctor of Laws in 2016.

Hagen, with his late wife Susan who was a prominent community leader, is the parent of two grown children and three grandchildren.

Ira M. Lubert is a Philadelphia real estate investor and private equity expert. In 1997, he founded Independence Capital Partners, a family of private equity and real estate funds. He is also Chairman and co-founder of Lubert-Adler Real Estate and co-founder of LLR Partners Inc., Quaker Partners, LEM Capital, LBC Credit Partners, and Patriot Financial Partners L.P.; all of which comprise Independence Capital Partners.

Prior to co-founding Lubert-Adler, he co-founded several other businesses, including TL Ventures, within the family of Safeguard Scientifics, Inc. (NYSE: SFE), an early-stage venture fund; Radnor Venture Partners, L.P., the first venture fund managed by Safeguard Scientifics; and GF Management, a hotel ownership and management company.

Outside of his professional obligations, Ira serves on the Boards at The Franklin Institute and National Constitution Center. He is a longtime advocate for the United Way of Greater Philadelphia and Southern New Jersey, and has served as a past Chair of the United Way Campaign and Tocqueville Cabinet. He remains an active recruiter for the Tocqueville Society.

Ira has received many honors for his business leadership and philanthropic endeavors. In 2014, Drexel University and Temple University both awarded him their most prestigious honors. He was named Drexel University's LeBow College of Business' 60th Business Leader of the Year, and Temple University's Fox School of Business honored his outstanding achievement, leadership and commitment to the community with the Musser Award.



He is a 1973 graduate of the Pennsylvania State University, where he received a Bachelor of Science degree in Human Development, with a major in Hotel Management. In 2006, he was the recipient of The Distinguished Alumni Award, which is the highest honor presented by Penn State to an outstanding alumna or alumnus. He previously served on Pennsylvania State University's Board of Trustees from 1997-2000 and today, serves as Chairman of the Board of Trustees.


